CALENDAR DESCRIPTION:

This course is designed to help students understand children's behaviour and what it means to use a positive guidance approach in supporting children's social, emotional, and moral development. Environmental and developmental factors which influence behaviour are examined, as are the principles of the guidance approach and ways in which these principles can be applied in early learning and child care settings.

COURSE OBJECTIVES:

- Explain how guidance, discipline and punishment differ in goals and practice.
- Discuss legislative policies and ethical practices relevant to guiding children’s behavior.
- Explain how development influences behavior.
- Identify environmental factors that can influence children’s behavior.
- Outline strategies practitioners can use to create positive interpersonal environments.
- Identify positive and respectful communication practices and attitudes in guiding children’s behavior.
- Discuss developmentally appropriate, positive prevention strategies when guiding children’s behavior.

LEARNING OUTCOMES:

Students will be able to differentiate between guidance, discipline and punishment.
Students will be able to articulate how development and environment influence behaviour.
Students will be able to outline strategies to create positive, respectful, developmentally appropriate environments.
Students will be able to discuss prevention and problem solving strategies when guiding children’s behaviour.
