#### **CD2070 Infant Toddler Care**

#### **Summary of Assignments**

#### Winter 2011

Your final grade will be based on the following:

Assignment One: Key Concepts for Quality 30% Due January 31, 2011 by 4:30 p.m.

1. Arrange to visit **two** infant/toddler day care programs. You are required to go to two different day cares not two programs in the same day care.

You must call the day cares ahead of time and make arrangements to visit. Ask to speak to the director. If you would like the director's name, contact me. No more than two students should visit a day care room at the same time. It may take you more than one visit to get all the information needed to thoroughly complete the assignment. Infants and toddlers have a nap in the afternoon. Please check what time the children will be napping and arrange for your visit outside this time period. Remember it is a privilege to be permitted to observe in a day care. Act respectfully at all times.

2. Using the **Key Concept for Quality** (pgs. 35-38 text) <u>describe in detail</u> what characteristics support or do not support these concepts. Consider each concept individually. <u>Provide specific examples</u> to justify your responses. <u>Take photographs</u>\*

For example: High Expectations for Every Child. You would observe and discuss with the room staff how the program recognizes individual strengths and challenges, the children's culture, as well as the family's desires and values. You would ask yourself and staff how the program works with families to help their child succeed in life. Does the program have goals and objectives for the children? Do they show knowledge of development? Do the child care workers complete formal observations? Do they communicate with families? You would then provide examples to support your answers. For instance the Infant room at Read-A-Lot Day Care supports the children's culture which is predominately native and by providing accurate modern day images of native peoples. The book centre has "Mama Do you Love Me" by Barbara Joosse and "My Kookum Called Today" by Iris Leowen. I have included a photo of the child care worker reading "Mama Do You Love Me" to the children. Note the carpet the children are sitting on. It displays traditional native motifs. Traditional native foods are part of the menu each week. This week bannock and moose stew was served on Wednesday. You would then continue with the other points in this concept.

Photos: You must have permission to take photos of the children. I have attached a letter that you can bring to the day care for the parents to sign. Please include these letters with your assignment.

# **Grading Criteria:**

Your assignment will be graded on the basis of:

- The thoroughness of your descriptions of the Key Concepts of Quality (Did you address all the points in each of the Eight Key Concepts?)
   20 marks
- Demonstration of your understanding of quality (Did you include examples to justify/explain your answers?)
   8 marks
- Submission of all requirements of the assignment including photos 2 marks
