CALENDAR DESCRIPTION:

This course examines the developmental characteristics of children ages 6 through 12 years and the components of high quality out of school care programs. Students will acquire the knowledge and skills to ensure that the environment, experiences and interactions meet the needs of school age children.

PREREQUISITE(S)/COREQUISITE: Completion of first year or consent of Department

OBJECTIVES:

1. Describe the physical, social, and emotional developmental characteristics of school age children and their motor, cognitive, communication, and creative skill development.

2. Describe strategies child care professionals can use to support and enhance all aspects of the development of school age children.

3. Identify the components of an effective, high quality out of school care program.

4. Develop and implement a program plan that considers the experiences, materials, and environment that best support the goals and philosophy of best practice in school age care.

REQUIRED TEXT/RESOURCE MATERIALS:

This course includes a textbook, as well as, a variety of resources and materials. The textbook you will need to complete the course is:

Caring for School-age Children, 2stCanadian Edition (Click, Parker, & Stone-Zukowski, 2013).

<u>Course notes</u> which include background information about each topic. Along with the information in the textbook and other readings, these notes are the "meat" of the unit and set the stage for other course activities.

Discussion Forum There will be a question posted to discuss during each Unit (for a total of 5 questions). As a minimum, you are expected to make one substantial posting with a thoughtful and substantial response to the question, to make one response to a posting that someone else has done (and your response needs to have thoughtful content -- not just a statement of agreement).

<u>Learning Activities</u> are special tasks for you to complete. Each of your completed learning activities is to be submitted to your instructor for feedback and marking.

<u>Self-checking Exercises</u> allow you to monitor your own understanding of course material. The answers to these exercises can be found in the appendix for each unit.

<u>Readings</u> include material from your textbook, journal articles in the Readings folder on the course website, and internet readings as indicated.

<u>**References**</u> which show you where important course information was obtained. To learn more about any specific topic in a unit, locate the article, book, or website cited in the references.

An Appendix which offers answers to the self-checking exercises in each unit.
