#### **CALENDAR DESCRIPTION**

This course builds on CD 1370 (Guiding Children's Behavior I) and provides an in-depth exploration of factors that influence children's behavior, as well as guidance strategies practitioners can use to build children's social competence. Emphasis is placed on the importance of the adult-child relationship as the foundation for children's social, emotional, and moral development. This course also offers strategies for coping with challenging behaviors, such as bullying, and for working collaboratively with parents to resolve behavioral issues.

**OBJECTIVES:** On completion of this course the student will be able to:

- 1. Explain how early childhood educators provide the support and guidance children need to develop healthy self- concepts and the ability to function well in their social world.
- 2. Explain how positive adult-child relationships provide the foundation for children's social, emotional, and moral development.
- 3. Explain how children's self-identity and self- esteem affect behaviour.
- 4. Identify challenging and aggressive behaviours and explain strategies that use a guidance approach to handling these types of behaviours.
- 5. Develop preventative interventions as a way of handling aggressive and challenging behaviours.
- 6. Describe genetic and environmental influences on behaviour.
- 7. Utilize observations to analyze, understand and guide children's behaviour.
